18 Complainant alleges:

19 **PARTIES**

20 1. Wood Robinson (Complainant) brings this Accusation solely in his official capacity  
21 as the Enforcement Supervisor I of the Contractors' State License Board, Department of  
22 Consumer Affairs.

23 2. On or about September 16, 2003, the Registrar of Contractors issued Contractor's  
24 License Number 824319, B, C-9, C-20 to The Energy Store of California Inc, Dennis Michael  
25 Barsam, RMO/CEO/Pres (Respondent). The Contractor's License was in full force and effect at  
26 all times relevant to the charges brought herein and will expire on September 30, 2015, unless  
27 renewed.

1 acts or omissions constituting grounds for discipline, and any licensee which employs, elects, or  
2 associates Dennis Michael Barsam shall be subject to disciplinary action.

3 14. Section 7095 of the Code provides, in pertinent part, that the Registrar in making his  
4 order may:

5 (a) Provide for the immediate complete suspension by the licensee of all operations as a  
6 contractor during the period fixed by the decision.

7 (b) Permit the licensee to complete any or all contracts shown by competent evidence taken  
8 at the hearing to be then uncompleted.

9 (c) Impose upon the licensee compliance with such specific conditions as may be just in  
10 connection with its operations as a contractor disclosed at the hearing, and may further provide  
11 that until such conditions are complied with, no application for restoration of the suspended or  
12 revoked licensee shall be accepted by the Registrar.

#### 13 DISCIPLINE CONSIDERATIONS

14 15. To determine the degree of discipline, if any, to be imposed on Respondent,  
15 Complainant alleges that on or about April 3, 2013, in a prior action, the Contractors' State  
16 License Board issued Citation Number 2 2012-1210 and ordered Respondent to pay a civil  
17 penalty of \$2,000.00 for violation of Business and Professions Code section 7110 for violation of  
18 Labor Code sections 1771 and 1774 for failing to pay prevailing wages to employees and for  
19 violation of Labor Code section 1775.5 for failing to pay training fund contributions. That  
20 Citation is now final and is incorporated by reference as if fully set forth.

#### 21 PRAYER

22 WHEREFORE, Complainant requests that a hearing be held on the matters herein alleged,  
23 and that following the hearing, the Registrar of Contractors issue a decision:

24 1. Revoking or suspending Contractor's License Number 824319, B, C-9, C-20 issued to  
25 The Energy Store of California Inc, Dennis Michael Barsam, RMO/CEO/Pres;

26 2. Prohibiting Dennis Michael Barsam from serving as an officer, director, associate,  
27 partner, or qualifying individual of any licensee during the period that discipline is imposed on

3 3. Revoking or suspending any other license for which Dennis Michael Barsam is  
4 furnishing the qualifying experience or appearance;

5 4. Ordering Respondent to pay the Registrar of Contractors her costs in the investigation  
6 and enforcement of the case according to proof at the hearing, pursuant to Business and  
7 Professions Code section 125.3;

8 5. Ordering Respondent to provide the Registrar with a listing of all contracting projects  
9 in progress and the anticipated completion date of each;

10 6. Taking such other and further action as deemed necessary and proper.
