WHEREAS, on March 4, 2014, the Honorable Patricia M. Murphy, Judge of the Superior Court, of the State of California for the County of Ventura, in proceedings entitled People of the State of California vs. William Jay Littlefield, Case Number 2013022511 FA, ordered that Mr. Littlefield shall not be employed in any capacity which involves home remodeling, home repair, home construction or home contracting, except when working as an employee of a licensed contractor, and ordered that Mr. Littlefield's contracting license be revoked.


WHEREAS, on April 23, 2014, the Honorable Donald D. Coleman, Judge of the Superior Court, of the State of California for the County of Ventura, in proceedings entitled People of the State of California vs. Doron Shaham, Case Number 2013032993 and 2013019297 FA, ordered that Mr. Shaham shall not be employed in any capacity where he is required to oversee construction or home improvement jobs, or as a sales representative for any construction or home improvement company, and ordered that Mr. Shaham's CSLB salesperson licenses, to the extent that he has them, be revoked.
